

Art Show Rules and Procedures

General Rules

- All artwork submitted MUST have a Science Fiction or Fantasy theme.
- CONFUSION reserves the right to refuse artwork on the basis of subject matter, quality or space limitations.
- Models, Miniatures and all other pre-cast commercially available forms <u>must</u> be custom modified.
- Limited Edition Prints of 1000 or less will be accepted in the Art Show. Prints with runs of over 1000 or multiple copies, will be accepted in the Print Shop. Computer art and Photographs may be entered in the Art Show if a paper certifying they are a limited edition of 1000 prints or less accompanies them. Computer art and Photographs that are not numbered may be entered in the Print Shop.
- Hanging works do not need to be framed; however artwork MUST be matted. <u>ALL work</u> <u>submitted must be marked on the back with</u> <u>the artist's name and the name of the piece.</u>
- CONFUSION uses the steel commercial grid hanging system for hanging art and standard hotel tables for 3-D art. All art must be presented on these venues. Any special display fixtures are only usable at the discretion of the Art Show director, the hotel management and the fire marshal. If you have special hanging fixtures, it is best to get permission in advance.
- Print Shop entries are not limited to 2-D work.
 All entries must be individually priced and labeled with the artist's name and the name of the piece.
- All space is limited and sold by the piece not the panel; the Art Show reserves the right to rearrange pieces in order to consolidate space for other artists to exhibit their work.
- CONFUSION will not be held responsible for artwork lost, stolen or damaged in transit or at the show and will not be responsible for artwork not picked up by closing of the show. This does not include mail-in art, which will be returned according to the instructions given in the artist's registration.

 The artist must sign and complete an Agreement Form before any works will be displayed.
 This form must be on file during the show.

Bidding and Auction

- All sales will be by written/voice bid only. There will be no quick sales.
- Sunday sales will be available for pieces without any bids. The Sunday Sale price will be the minimum bid unless the artist specifies otherwise.
- Items will be sold to the highest bidder.
- CONFUSION will have a Voice Auction. Items will be sold in this system if they receive 3 written bids.

Fees and Commissions

- There is a \$.50 hanging fee for pieces with minimums of less than \$100.00. Pieces priced at \$100.00 or more and Not For Sale (NFS) have a \$1.00 hanging fee.
- Hanging Fees will be waived for Artists that attend the convention and stay at the Troy Marriot.
- There is no hanging fee for the art shown in the Print Shop. The Art Show may limit entries into the Print Shop in order to insure diversity.
- CONFUSION charges a 10% commission on <u>ALL</u> sales: Silent Auction, Voice Auction & Print Shop.
- All payments for pieces sold are by corporate check. CONFUSION reserves the right to withhold monies previously owed to CONFUSION from any monies due the artist.
